NYSDA event hosted by the Albany Aquanauts

WHEN: September 9 - 13, 2010 (Thursday, 12:00 pm through Monday, 11:00 am)
WHERE: Rogers Rock Campground on Lake George, NY (*When entering the campground, tell them you are with the Albany Aquanauts at the Association Area.*)

DIRECTIONS: The campground is on Route 9N, lakeside, 3 miles north of the Village of Hague.

Getting to Hague:

- From the Northway (I-87) via Exit 25:
Take Route 8 East to Hague. Turn left (north) on to Route 9N.
- From the Northway (I-87) via Exit 24:
Take County Route 11 East. Turn left (north) on to Route 9N through Hague.
- From Lake George Village:
Take Route 9N North to Hague.

If you are towing a boat, you might want to consider going through Ticonderoga.

- From the Northway (I-87) via Exit 28:
Take Route 74 East through Paradox and Chilson to Ticonderoga, then Route 9N South to the campground.

REGISTRATION FORM: The attached "Registration Form & Liability Release" must be completed for each household and must be submitted along with the appropriate fee.

FEES: Camping fee: \$ 15.00 per person age, 15 years and older
The camping fees are for the weekend, regardless of the duration of your stay. Campsites in the Association Area are on a first come first serve basis. Remember, campsites may be reserved outside the Association Area, but are not subject to the above fee and must be paid directly to Rogers Rock State Park. However the "Day Use" fee is still required to dive from the Association Area.

or Day Use fee: \$ 5.00 per person, age 15 years and older
This is a one time fee for those divers visiting the Association Area for day or multi-day use only.

Saturday catered dinner (pre-registration preferred): \$ 15.00 per person
Back by popular demand, we will have homemade catering by our Aquanauts' club members Judy & John Grattidge! Dinners not reserved in advance will only be available in limited quantities.

Boat mooring fee: Pay your boat mooring fee at the campground entrance.
Note: Due to space limitations, boat trailers are NOT ALLOWED in the Association Area.

Raffle: The Albany Aquanauts will have a 50/50 raffle on Saturday evening following the NYSDA club meeting. Attendance is not required to win.

Air fills: Tank fills will be available on-site as well as at the Northern Lake George Resort.

LIABILITY RELEASE AND ASSUMPTION OF RISK AGREEMENT:

All event attendees age 15 and older (divers & non-divers) must read the following and sign below.

I understand and agree that neither Albany Aquanauts, Inc. nor its members or officers (hereinafter referred to as "Released Parties") may be held liable or responsible in any way for any injury, death, or other damages to me, my family, estate, heirs, or assigns that may occur as a result of my participation in this event or as a result of the negligence of any person, including the Released Parties, whether active or passive. In consideration of being allowed to participate in this event, I hereby personally assume all risks of this event. I further release, exempt, and hold harmless the Released Parties from any claim or lawsuit by me, my family, estate, heirs, or assigns, arising out of my participation in this event.

I hereby affirm that I am aware that skin diving and scuba diving have inherent risks that may result in serious injury or death. I understand that diving with compressed air or other gases involves certain inherent risks, which include decompression sickness, embolism, or other hyperbaric injury that require treatment in a recompression chamber, and I understand that this event may be conducted at a site that is remote, either by time or distance or both, from such a recompression chamber. I still choose to participate in this event in spite of the possible absence of a recompression chamber in proximity to the site.

I also understand that skin diving and scuba diving are physically strenuous activities, and that if I am injured as a result of a heart attack, panic, hyperventilation, drowning, or any other cause, that I expressly assume the risk of said injuries and that I will not hold the Released Parties responsible for the same.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian.

I understand the terms herein are contractual and not mere recital, and that I have signed this document of my own free will and with the knowledge that I hereby agree to waive my legal rights. I further agree if any provision of this document is found to be unenforceable or invalid, that provision shall be severed, and the remainder of this document will then be construed as though the unenforceable provision had never been contained herein.
